ADVOCACY IS PROVIDED IN OUR EMERGENCY SHELTER AND COMMUNITY ADVOCACY PROGRAMS. THIS INCLUDES DIRECT SUPPORT TO SURVIVORS OF DOMESTIC AND SEXUAL VIOLENCE AND THEIR CHILDREN. ADVOCATES PROVIDED ASSISTANCE THROUGH THE 24-HOUR CRISIS LINE OVER 2867 TIMES AND IN-PERSON CRISIS RESPONSE 2228 TIMES. CASE MANAGEMENT AND GOAL PLANNING WAS OFFERED TO 67 ADULT SHELTER RESIDENTS, WITH ADDITIONAL SUPPORT FOR PARENTS AND THE
